The reservation deposit is to be paid at time of booking the services. The reservation deposit is applied towards the purchased photography package.

Patty Jasso {Photographer} takes all precautions in delivering a valuable product; however in the event that photographic materials are damaged in processing, lost through camera malfunction, lost in the mail, or otherwise lost or damaged without fault on the part of the Photographer; Or in the event that Patty Jasso {Photographer} fails to perform for any other reason, the photographer shall not be liable for any amount in excess of the retail value of the client's order.

Patty Jasso {Photographer} will coach you 100% of the way with poses, facial expression, etc, the clients' cooperation is extremely important, please feel free to point out a specific scene or pose desired before the session begins. Patty Jasso {Photographer} shall not be responsible for photographs not taken as a result of the client's failure to provide reasonable assistance or cooperation.

4. At the time of the scheduled photo session, please only bring the client/clients that will be photographed. Also, please do not bring your own camera, camcorder, or recording device. Outside flashes, cell phones and distractions will most certainly take away from your images.
